FROM CAGES TO COMMUNITY CARE: Courtwatch PG volunteers have witnessed and documented thousands of bond review hearings over the past two years. Black and Latino Prince Georgians — especially Black mamas and caretakers, young people, and those living with mental health diagnoses — represent the overwhelming majority of those arrested and held pretrial in Prince George's County although Black, Latino and white Prince Georgians commit harms at approximately the same rates.

Although Maryland underwent cash bail reform in 2017 through an administrative judicial ruling (4-216.1) Courtwatch PG has witnessed prosecution and judges

use cash bail as a tool to separate loved ones from their freedom, The Maryland Court of Appeals adopted new Rule 4-216.1 in February 2017 to provide guidance to judges regarding pretrial release of arrested individuals. The rule was designed to encourage courts to release more defendants on PR and unsecured bonds, according to the rules.
